Fee Bylaws

#### Title

These Bylaws may be referred to as *The SCPT Fee Bylaws*, 20204 (No. 2).

## **Registration application**

The non-refundable processing fee payable for an initial application for registration as a practising member is \$75.00 \$100.00.

#### Non-practising

The annual fee for a non-practising membership is  $\frac{$125.00}{150.00}$ .

## **Change of status**

The fee to change status from non-practising to practising and for the relevant licence to practice in the year in which the change in status occurs is the amount of the licence fee described in subsection 7(1), less the non-practising fee described in section 3.

## **Temporary licence**

The fee for a temporary licence as a registrant in or instructor of a course is \$50.00 per course.

# Licence monitoring fee

- 6(1) The following persons shall pay a licence monitoring fee of  $\frac{$75.00 $100.00}{}$ :
  - (a) each new applicant for a restricted practising licence;
  - (b) each applicant for a full practising licence who has insufficient hours as provided for in subsection 12(2) of *The SCPT Regulatory Bylaws*;
  - (c) each applicant for a licence who is subject to limitations or conditions attached to the licence as a result of an order of the discipline committee or an consensual resolution agreement with the professional conduct committee.

#### **Practising licences**

- 7(1) The annual fee for licensure as a full practising, restricted practising, or academic practising member is \$500.00
  - (a) for the 2024 calendar year, \$500.00;
  - (b) for the 2025 calendar year, \$575.00;
  - (c) for the 2026 and subsequent calendar years, \$650.00
- (2) The annual fee for licensure as an extended access member is \$125.00.
- (3) The fee for licensure in the first year of registration is reduced by 50% in the case of a person who applies on or after October 1 in any year.

- (4) The fee for a member who wishes to renew their licence only for the period from April 1 to September 30 in any year is 50% of the fee prescribed in subsection (1) plus a \$50.00 administrative fee.
- (5) All renewal fees are payable before March 1.
- (6) A person who pays the required licence renewal fee on or after March 1 but prior to March 31 shall, in addition, pay a late fee of \$100\_\$200.00, plus \$10\_\$20.00 per day for each day late.
- (7) A person who fails to pay the required licence renewal fees by March 31 ceases to be a licensed practising member as of that date.
- (8) A person who fails to pay the required licence renewal fee by March 31 may subsequently apply to be re-licensed on payment of:
  - (a) the applicable licence renewal fee;
  - (b) the penalty described in subsection (7); and
  - (c) an additional re-licensing fee of \$100.

### Other fees

- 8(1) The fee to change a member's name with the SCPT is \$25.00.
- (2) The fee to complete and send a Registration History to another jurisdiction is \$50.00.
- (3) The fee to apply for the SCPT Practice Based Assessment is \$650.00.

## Remission of fees

The Council may, for cause, remit the whole or any portion of any fee or late payment penalty.

#### Repeal
